What We Do

Community Legal Aid helps people obtain safe and stable housing, access benefit programs to stabilize their income, obtain needed services in school, and break free from domestic violence and other abuse and exploitation. We help with:

- Eviction defense and housing discrimination
- Family law issues (divorce, custody, visitation, child support for domestic violence and sexual assault survivors)
- Abuse and harassment prevention orders
- Special education and school discipline issues
- Employment discrimination and unemployment
- DCF cases arising from poverty-related challenges (Hampden County)
- Government benefits (TAFDC, EAEDC, Food Stamps/SNAP, Veterans' Benefits)
- Social Security, Supplemental Security Income (SSI), and state supplemental benefits
- Health care benefits (including MassHealth and Medicare), nursing home issues, and elder neglect
- Re-entry after incarceration (criminal record sealing, accessing housing and jobs)
- Accessing homeless shelters
- Debt collection and bankruptcy
- Wills, estates, and Probate Court matters (trusts, powers of attorney, health care proxies, name changes)
- Humanitarian-based immigration relief*
