# SEXUAL **VIOLENCE** & FAIR HOUSING

## You have the right to be safe in your home.

Survivors of domestic violence, sexual assault and harassment, and other forms of gender-based violence all too often face instability in their housing.

This can take the form of:

- Eviction
- Termination of public or subsidized housing
- Denial of public or subsidized housing or a housing voucher

When that eviction or denial is because of violence that person experienced, it could be discrimination.

### **KNOW YOUR RIGHTS**

# Sexual Harassment is considered sex discrimination under the Fair Housing Act.

Sexual harassment includes any unwelcomed sexual advances, sexual comments, or any request or demand for sexual favors by a landlord or maintenance worker.



The Fair Housing Act protects people regardless of gender.



You are also protected from retaliation if you report any sexual harassment (this may include changed locks, increased rent, withholding maintenance).

## Under Massachusetts state law, you have the right to:



To end your lease early or request a transfer.



To have your locks changed.



To report discrimination.

The fact that you exercised these rights with a current or past landlord cannot be held against you by a future landlord.
